

2024 Democratic National Convention Declaration of Delegate Candidacy

THIS FORM MUST BE COMPLETED, SIGNED, AND RECEIVED NO LATER THAN 5:00 P.M. ON MARCH 8, 2024, TO BE A CANDIDATE FOR NATIONAL DELEGATE.

A total of 23 District-Level Delegates have been allocated among Oklahoma's Congressional Districts (CDs), 5 Party Leader and/or Elected Officials (PLEOs), and 8 At-Large and 3 At-Large Alternate Delegates from across the state, will be elected at the Oklahoma Delegate Selection Convention on April 6, 2024. Delegates will be allocated to presidential candidates in a manner that fairly reflects the expressed presidential preference of the primary voters within each respective CD.

Any registered Democrat can run to be a National Delegate at the Oklahoma Delegate Selection Convention. However, only certified ODP State Delegates may vote on candidates for National Delegate at the Delegate Selection Convention.
